## Item 1.1 REVIEW OF CONSULTATION PROCESS AND CRITERIA FOR SETTING SPEED LIMITS IN NSW

#### **Resolved**

THAT Council:

 Endorses Mayoral advocacy on behalf of Leeton Shire to the Minister for Regional Transport and Roads, the Hon. Paul Toole MP, calling for TfNSW to increase and improve its consultation with local authorities well before the installation of new speed zones in NSW, with such consultation needing to be both authentic and timely, and noting that the reasoning behind revised speed zones requires the thorough assessment of safety risks.

2. Endorses Mayoral advocacy that RAMJO, Country Mayors and LGNSW be asked to collaborate on a campaign calling for more sensible application of speed zones.

- 5. Signage stating that the VIC is temporarily operating from the Leeton Museum and Gallery be prominently displayed at the VIC during the Christmas/New Year period.
