- 5. In accordance with Section 413 (2) (c) of the Local Government Act 1993 authorises the Mayor, the Deputy Mayor, the General Manager and the Responsible Accounting Officer to sign the required statements by Councillors and Management relating to the Statements.
- 6. Delegates to the General Manager the authority to lodge the signed Statements and Audit Reports (as noted below) and Special Schedules with the NSW Office of Local Government (OLG) and to put the Statements and Audit Reports and Special Schedule on public display upon receipt of the Audit Reports.
- 7. Endorses the Internal Restrictions as at 30 June 2021 as detailed in **Attachment 1**.
- 8. In anticipation of receiving the Audit Reports on 29 October 2021, sets the Ordinary Council Meeting to be held on 24 November 2021 as the meeting date that the Statements and Audit Reports and Special Schedules will be presented to the public for review and comment. Note: The meeting date must be at least 7 days after the date on which notice is given, but not more than 5 weeks after the Audit Reports are given to Council.
