#### **GENERAL MANAGER'S MATTERS**

#### Item 7.1 PROPOSED SPECIAL RATE VARIATION

#### 22/177

#### Motion

#### THAT Council:

- 1. Approves the General Manager to proceed with an application to IPART, for a Special Rate Variation of 45.44% (compounded and above the rate peg) over 5 years, being 8% for the first 3 years and then 7.5% and 7.4% for the following 2 years, resulting in total rate increases of 65.63% (compounded and including the rate peg) over 5 years, commencing 1 July 2023.
- 2. Approves the General Manager to update the Long Term Financial Plan 2022–2032 in accordance with the above Special Rate Variation, and for the Long Term Financial Plan to include the following:
  - a) Total savings of \$290,000, allocated as \$100,000 during 2024/25, \$100,000 during 2025/26 and \$90,000 during 2026/27.
  - b) A commitment to allocate any proceeds from the sale of Council's investment water, that is over and above what is in the Long Term Financial Plan, to offset future rate increases.
- 3. Commits to undertaking a minimum of 2 service reviews per annum to ensure that Council's services are being provided as efficiently as possible.
- 4. Investigates offering additional concessions to eligible pensioners, over and above that for domestic waste management, water and sewerage services under section 575 of the Local Government Act 1993, with effect from 1 July 2023.
- 5. Considers the equity of the rating structure as part of the update of 2022–2025 Delivery Program by no later than April 2023, in order to take into account the anticipated revaluation by the Valuer General of the unimproved land values and having particular regard to fairness for ratepayers in the farmland category.
- 6. Signals to ratepayers its intention to undertake a comprehensive review of the implementation of the Special Rate Variation at 3 years, being 1 July 2026, in order to ensure its continuation for the remaining 2 years continues to be warranted.
