#### Item 6.1 ACCOUNTING TREATMENT OF RURAL FIRE SERVICE ('RED FLEET') ASSETS

# <u>Resolved</u>

- 1. Writes to the local State Member(s) Helen Dalton MP, the Treasurer the Hon Matt Kean MP, Minister for Emergency Services and Resilience the Hon Stephanie Cook MP and the Minister for Local Government Wendy Tuckerman MP:
  - a. Expressing Council's objection to the NSW Government's determination on ownership of Rural Fire Service assets;
  - b. Advising of the impact of the Government's position on Council finances of this accounting treatment, to the extent known;
  - c. Informing that Council will not carry out RFS assets stocktakes on behalf of the NSW Government and will not record RFS assets in Leeton Shire Council's financial statements;
  - d. Calling on the NSW Government to take immediate action to permanently clear up inequities and inconsistencies around the accounting treatment of Rural Fire Service (RFS) assets by acknowledging that rural firefighting equipment is vested in, under

the control of and the property of the RFS; and

- e. Amending s119 of the Rural Fires Act 1997 so that the effect is to make it clear that RFS assets are not the property of councils.
- 2. Writes to the Shadow Treasurer Daniel Mookhey MLC, the Shadow Minister for Emergency Services Jihad Dib MP, the Shadow Minister for Local Government Greg Warren MP, the Greens Spokesperson for Local Government Jamie Parker MP and the leaders of the Shooters, Fishers and Farmers, Animal Justice and One Nation parties Robert Borsak MLC, Emma Hurst MLC and Mark Latham MLC:
  - a. Advising Members of Leeton Shire Council's position, including providing copies of correspondence to NSW Government Ministers; and
  - b. Seeking Members' commitments to support NSW Councils' call to amend the *Rural Fires Act 1997* as set out in correspondence.
- 3. Writes to the Auditor General advising that notwithstanding any overtures of future qualified audits, it will not carry out RFS stocktakes on behalf of the NSW Government and will not record RFS assets in Leeton Shire Council's financial statements, noting that the State Government's own Local Government Accounting Code of Practice and Financial Reporting provides for councils to determine whether or not they record the RFS assets as council assets.
- 4. Promotes these messages via its digital and social media channels and via its networks.
- 5. Re-affirms its complete support of and commitment to local RFS brigades noting that Leeton Shire Council's action is entirely directed towards the NSW Government's nonsensical position that rather than being owned and controlled by local brigades, RFS assets are somehow controlled by councils, which councils consider to be a cynical financial sleight of hand abdicating the NSW Government's responsibilities at the cost of local communities.
- 6. Affirms its support to Local Government NSW (LGNSW) and requests LGNSW continue advocating on Council's behalf to get clarification finally from the State Government about the accounting treatment of RFS assets.

# PROPOSED MOTION 1: ADDRESSING POORER HEALTH OUTCOMES IN RURAL, REGIONAL AND REMOTE NSW

THAT LGNSW urges the NSW Government to partner with the Federal Government to:

- immediately commence implementation of the health reforms recommended in Upper House Inquiry - Report 57 – "Health Outcomes and Access to Health and Hospital Services in Rural, Regional, and remote NSW"
- focus first on the recommendations aimed at recruiting and retaining doctors and clinicians in rural and remote areas of NSW
- increase the intake of overseas-trained doctors and other medical staff to give immediate relief to rural and remote locations experiences shortages of trained medical personnel
- ensure there is improved health service governance and greater transparency at the local level.

# PROPOSED MOTION 2: Increasing the Supply of Affordable Housing in Rural NSW

THAT LGNSW calls on the NSW Government to work collaboratively with other levels of government, key bodies and interest groups to – as a matter of priority provide direct financial, land and infrastructure support for affordable housing in rural NSW growth areas.

# PROPOSED MOTION 3: Making 'Temporary' Refugees Permanent

THAT LGNSW calls on the NSW Government to work with the Australian Government to expeditiously transition refugees on Temporary Protection Visas or Safe Haven Enterprise Visas to Permanent Protection Visas to safeguard the health and wellbeing of these 'temporary' refugees and enable them to contribute to contribute to the economic and social fabric of the communities they have chosen to call home.

# PROPOSED MOTION 4: Inquiry into Ownership of RFS Assets

THAT LGNSW lobbies the NSW State Parliamentary Accounts Committee, and/or other more relevant Committees, to:

- Conduct an inquiry into who effectively owns and controls Rural Fire Service (RFS) red fleet assets
- Set up a formal (independent of government) appeals process for sectors audited by the NSW Audit Office where there is professional disagreement that results in qualified audit opinions, and
- Amend s119 of the Rural Fires Act 1997 so that the effect is to make it clear that RFS assets are not the property of local councils.

# PROPOSED MOTION 5: Increased Funding for Weed Management

THAT LGNSW calls on the NSW and Federal Governments to provide greater levels of funding to local councils to enable better protection of agricultural land and the environment from problem weed incursions.
