SUMMARY/PURPOSE

The purpose of this report is to advise Council of an application received for funding assistance (**Attachment 1**) through Council's Community Strengthening Grants under the Youth Development Category.

RECOMMENDATION

THAT Council awards Jett Teerman a \$250 Youth Development Grant to assist with the costs associated with representing Leeton and the Riverina at the Little Athletics New South Wales State Championships in Sydney, NSW on 19–20 March 2022.

REPORT

(a) Background

The Community Strengthening Grants program includes a 'Youth Development' Grant Category which is offered at a set amount of \$250 per applicant and is available to support high achievement in a cultural, academic or sporting activity that requires attendance at a State, National or International level event.

A request has been received from Jett Teerman for financial assistance to attend the Little Athletics New South Wales State Championships in Sydney, NSW from 19-20 March 2022.

The request for funding assistance was lodged with Council on Friday 18 February 2022.

(b) Discussion

Jett participated at the Riverina Region 4 Track and Field Championships in the Under 9 Boys Shot Put event on 5-6 February 2022 and placed second. The first two places in this event automatically progress to compete at the State level.

Community Grants Assessment Committee member, Cr Smith, declared a less-than-significant non-pecuniary conflict of interest in this application. Cr Smith has recently engaged the business services of the applicant's mother.

(c) Options

Council has the following options available:

1. Approve the application for a grant of \$250. **This is the recommended option.**
2. Reject the application.

IMPLICATIONS TO BE ADDRESSED

(a) Financial

The Quick Response and Youth Development Category of the Community Strengthening Grants program has an annual budget of \$10,000. Each year \$1,175 is allocated for annual donations to each school in the Shire for end-of-year presentations. To date, \$500 of the allocation has been utilised for Youth Development Grants and \$4,099 has been utilised for Quick Response Grants. This leaves \$5,401 in the budget for Quick Response and Youth Development Grants. If the application being tabled at this Council meeting is approved by Council, there will be \$5,151 remaining in the budget.

This application meets the eligibility criteria stated in Leeton Shire Council's Grants Program Guidelines and Application Instructions for 2021/22.
